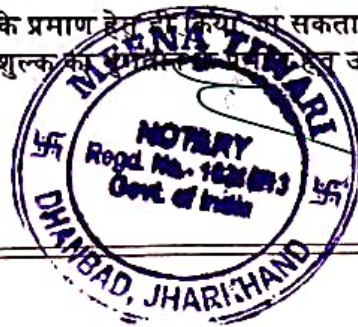

The school undertakes to abide by the provisions contained in the affiliation & examination byelaws , direction issued from time to time and the law of the land .
8. That the school will ensure compliance of all statutory requirement like EPF, ESI and Labour laws etc. with respect to the school and staff of the School .
9. That the school will ensure that the Building Safety , Fire Safety , Water , Safety Health and hygiene certificates are being issued or renewed by the concerned Municipal or state authorities from time to time as per the prescribed term.

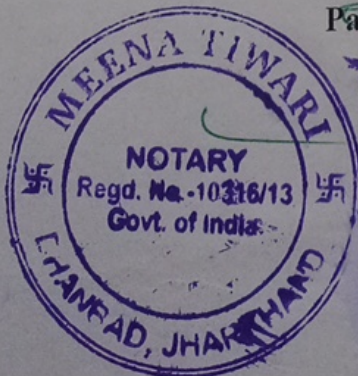
